

# Mould Protection Impregnation Anti Schimmel Impraegnierung

## Description

Permanent protection against new formation of mould. Odourless, therefore suitable for living rooms, bedrooms and children's rooms. For decorated or painted walls as well as tiles and masonry.

## **Action**

Transparent and odourless liquid for the prevention of the formation of mould in indoor areas. Long-term protection against mould (re-)infestation with moulds, algae and mosses on wall and ceiling surfaces with unfavourable humidity ratio. Prevents fungal growth and reduces absorption of humidity.

## Scope of application

For application on places which are particularly at risk (window corners, behind furniture and wall coverings) in living rooms and bedrooms, kitchens, sanitary facilities and sauna area, in cellars as well as in all other rooms with increased humidity. Also suitable for children's rooms.

Can be applied on all absorbent surfaces such as decorated or painted walls and ceilings, tiles, joints, plaster, concrete, bricks, sand-lime bricks, plasterboard panels, wood and the like.

The surfaces can be over-papered or painted after treatment.

# **Application**

Remove any existing moulds or spores prior to treating the surface. Use Glutoclean chlorinated Mould Remover for removal in the sanitary area or Glutoclean chlorine-free Mould Remover for washable surfaces and in the living areas or on absorbent surfaces.

Let the surface dry well after cleaning. Afterwards, spray the anti-mould impregnation area-wide and at least 1 m beyond the place at risk and allow to dry.

#### Please note

Always check surface compatibility before application. Moulds and their spores represent a serious hazard to health. Therefore, they should be completely eliminated and their new formation prevented. One cause for mould formation is increased air humidity, therefore, allow regular ventilation for the exchange of room air (so-called shock ventilation for 5-10 minutes with the window wide open).
