# Application

Thoroughly pre-wet the stone surfaces to be cleaned, particularly in the joint area. Dilute Stone Cleaner S up to 1:5 with water and

apply with brush, wide brush or paint-brush onto the surface (do not

spray on). In so doing, work from bottom to top and in sections so as

to prevent the cleaner from drying. Clean the surface shortly after application using a hard brush and thoroughly rinse with plenty of water. Collect rinsing water and cleaner residues and dispose of in accordance with the official regulations.

### Note

Always test for surface compatibility before application and do preliminary tests to ascertain suitability and consumption prior to usage. Avoid contact with glass, metal, enamel and chrome surfaces as well as other surfaces sensitive to acids. Cover surfaces not to be treated prior to usage. Immediately wash off accidental splashes using plenty of water. Lime-containing natural stones, such as marble, shell limestone, calcareous sandstone and travertine as well as various granite types are sensitive to acids. Application of Stone Cleaner S can cause irreversible damage. Be sure to test prior to usage.
